

Air - Diving, Instrument & Zero



Description

Is a mixture of mainly Nitrogen and Oxygen gases. It is a non-flammable gas which is odourless, and colourless. Air is the Earth's natural atmosphere.

Zero Air is a mixture of pure Nitrogen and Oxygen (to eliminate impurities found in air).

Applications

- Industrial compressed air is employed as a source for burning and various industrial oxidation processes.
- Other common uses include the operation of pneumatic tools, starting diesel engines and 'pigging' pipelines.
- Industrial EHP Air is supplied at higher pressures in extra high pressure, cylinders of great capacity.
- Instrument Grade Air is used for non-critical instrument use.
- Diving Grade Air is used for scuba diving.
- Zero Air is used in calibrating environmental & other instruments, and used as an oxidant in Gas Chromatography FID (Flame Ionization Detection).
